

# Official Rules for the Taco Bell Foundation Summer of Inspiration Virtual Sessions Sweepstakes

## 1. CAN I TAKE PART?

The Taco Bell Foundation Summer of Inspiration Virtual Sessions Sweepstakes (“Sweepstakes”) is open to Live Más Scholarship recipients who attend one or more virtual sessions at the Live Más Scholarship Summer of Inspiration virtual conference (“Conference”). The Sweepstakes is subject to all applicable federal, state and local laws and regulations and is void where prohibited. Taco Bell Foundation (“Sponsor”) reserves the right, at any time to verify eligibility requirements, in any manner it deems appropriate. By participating, entrants agree to these Official Rules, which are final and binding in all respects. Limit one (1) entry per person per Conference session. Scholars can enter to win for as many Conference sessions as they attend.

**2. ENTRY PERIOD:** The Sweepstakes begins, July 14, 2020 and ends on August 31, 2020.

## 3. HOW DO I ENTER?

To enter, Live Más Scholarship recipients need to register and attend one or more virtual sessions part of the Conference for the full duration of the session (e.g. 60 or 90 minutes). The Conference is open to Live Más Scholarship recipients only and the Taco Bell Foundation will provide an access code to all scholars to be able to register.

## 4. WHAT CAN I WIN?

There will be one at least (1) winner randomly drawn from all eligible entries received for each session of the Conference. Prizes consist of any of the following, which will be chosen based on availability and based on the discretion of Sponsor:

- Access to [High Performing Student](#) – a personal and professional development program (limit: up to 25 winners). Valued at \$19.
- Access to The Leadership Launch – a leadership and entrepreneurship program by Olympian Sarah Wells (limit: one winner). Valued at \$1,000.

## **6. HOW DO I FIND OUT IF I WON?**

Potential Winner will be notified via email or phone on or about 5-7 business days after the session took place. Any Potential Prize Winner who does not accept the prize, has violated any Official Rules, or is ineligible will be disqualified. All prizes must be claimed within 30 days of such notification or the prize will be forfeited and may be awarded to an alternate winner at Sponsor's sole discretion.
